BOE Meeting 10/26/10

- 1. We like to highlight student organizations that conduct Community Service Projects, however this month we highlight all schools for participating in a project that will help the community. This Friday, all schools will have "hat day" to support the Haleyville Fire Department's purchase of new lights and decorations for "Christmas on the Lake." As most are aware, the ones used for the last several years were destroyed in the fire that gutted Fire Station #2 at the airport recently. "Christmas on the Lake" has been a highlight of the season for many years and it is our hope that with the cooperation of our great community, we will be able to enjoy the spectacle again this year. - 2. On behalf of the Board and myself, words cannot describe the pride we have for this school system and community. The display of patriotism and condolences for the Forester family during the week of Mark's memorial service was unparalleled anywhere in the country. Once again, Haleyville has shown what a loving, caring and giving community it is and we are proud of our students, faculty, staff and administrators for their participation in recognizing our own fallen hero, Mark Forester.

Every school system is required to have a minimum of 10 local mills of property tax earmarked for education. The 10 mills is made up of several different tax referendums which expire at different times. Winston County had a renewal a few years ago and renewed 3 mills with a strong majority. These renewals require a "Super Majority" or 2/3 of the vote. Amendment 2 changes the requirement from a Super Majority to simply a "Majority." Other tax referendums only require a simple majority and I encourage a "Yes" vote for Amendment 2.
- 4. The next Regular Session of the Haleyville City Board of Education is scheduled for Tuesday night, November 23, 2010 at 7:00, in the Board Room of the high school with a Work Session before if needed.
