**BOE Meeting** 4/26/11

- The year is quickly coming to an end and the State Legislature has not passed a budget nor have we received our Federal Entitlement allocations. Such being the case, as a local Board of Education, certain personnel actions must be taken in order to protect the system financially. Support or classified personnel decisions require a different time line than teacher or certified personnel action. Therefore the action taken tonight and unless a budget is passed before our next meeting, additional personnel action may be required in May. This is not to be dismal, but only to be realistic. The legislature is also considering several bills that, if passed, will change the way public schools in Alabama operate. We are in a "wait and see" pattern which makes planning for next year and beyond extremely difficult. As in the past, this Board will make decisions first and foremost based on what is best for our students, while keeping in mind the needs our loyal faculty and staff. Your thoughts and prayers are requested and very much appreciated during this process.
- As a reminder, any current employee who is required to file an Economic Statement of Interests or "Ethics Report" with the State of Alabama for last year, must do so by April 30<sup>th</sup>. This applies to those who have retired within the past year and also Board members. Time is of the essence or a daily monetary penalty may be imposed to the individual. All

personnel who qualify to file an Ethics Report have been properly notified. The form can be completed and filed online at www.ethics.alabama.gov. In addition to filing the report, a video or webinar explaining the recent changes must be viewed and a copy of the Certificate of Completion must be on file at the Central Office. If assistance is needed, please contact the Central Office.

- This Board held a Work Session last night with all members present at the Albright Administrative Building. Discussions centered on state and system financial conditions, personnel needs for 2011-2012 with reports from principals, along with short and long term objectives of the system. No official action was taken.
