Lunch full paid student HES **\$1.75**, HMS and HHS **\$2.00**, reduced student **\$.40**, Faculty, all schools, **\$2.50**, visiting adult, **\$3.00**, visiting child **\$2.25**, extra milk **\$.30**.

To consider approving Haleyville Middle School Lunchroom to enter into contract with Haleyville Mental Health – O’Kelley Center to furnish up to 20 lunches per day during the 2012-2013 school year beginning August 20, 2012 (or the first day of school) and ending May 23, 2013 (or the last day of school) for the following prices: child lunch **\$2.50** and adult lunch **\$3.25**.
